Medicare doesn't cover long-term care (also called Custodial care), if that's the only care you need. Most nursing home care is custodial care. Your costs in Original Medicare You pay 100% for non-covered services, including most long-term care.

For the first 20 days, Medicare will pay for 100 percent of the cost. For the next 80 days, Medicare pays 80 percent of the cost. Skilled nursing beyond 100 days is not covered. Individuals who have a Medicare Advantage plan have at least the same coverage as mentioned above, and perhaps, have additional coverage.

Although Medicare covers long-term hospital care, you could face significant charges if you receive long-term care beyond three months. In 2020 under Medicare Part A, you generally pay \$0 coinsurance for the first 60 days of each benefit period, once you have paid your Part A deductible. For days 61-90, you pay \$352 per day of each benefit period.
